**Attention: Candidates belonging to SC/ST/OBC/SBC/VJNT having caste / validity certificate issued by MH authority and eligible to apply for Gol Freeship / Scholarship**

Students of first to final year of B Tech/B Arch program of above category are requested to note that the institute name is yet to be approved by DSW for online E-Scholarship for year 2014-15. Hence there is delay in online application by student. It has been informed by DSW that shortly it will be made operative. Notice shall be displayed immediately on receiving the information by DSW.

All Fresh / Renewal student shall keep their documents ready for the purpose. Fresh student shall immediately create their log in as new registration and submit the data. All above category students compulsorily will be required to apply **on-Line** for claim of fees and other allowance. Any student falling in above category and do not apply in online e-scholarship module, shall have to pay the prescribed fees. Their online registration of courses shall be withdrawn in case of non application.

Students of SC/ST category will not be required to pay institute fees in case of student application/claim is registered by the student.

Students of OBC/VJNT/SBC category will not be required to pay institute fees except development fees component of fees. Gol scholarship / Free ship is applicable only to above category student whose parent's income is not exceeding 4.5 Lac p a. Student whose parent's income is exceeding 4.5 Lac p a. will be required to pay full fees.

However all such student shall apply online in DSW e-scholarship module, else their course registration shall be hold and will be required to pay fees. Students whose parent's income is not exceeding 4.5 Lac p a. are only eligible to apply and students whose parent's income is observed exceeding 4.5 Lac p a. at later stages will have make payment of full fees.

Please note online submission of application is mandatory to all above category students concerned. Else full fees payment will be applicable.
